

-- Farm Policies --

DeBuck's Family Fun Farm reserves the right to refuse or revoke admission to anyone engaging in, or appears to be engaging in, inappropriate or offensive conduct, as determined by our staff.

Pets may present health and safety issues for both guests and our animals; therefore they are not allowed on the premises, including the parking lot or inside parked cars. Trained service dogs are permitted.

Trained service dogs that are leashed and properly restrained are welcome at DeBuck's Family Fun Farms. Guests with a service dog are asked to alert a staff member at admissions upon arrival for approved entry. Dogs whose sole function is to provide comfort or emotional support do not qualify as service dogs under the ADA and are not permitted at DeBuck's Farms.

Children must be under adult supervision. Please report lost children or separated guests to the nearest staff member. We will respond and initiate protocols right away. Should you become separated, experience has shown that most are found within minutes in the same area where the child was last seen.

DeBuck's Family Fun Farm is an alcohol, vapor and smoke-free environment.

DeBuck's is not responsible for lost, stolen or damaged items.

Play at Own Risk. Not responsible for injuries. Adult supervision required.

Weather

Refunds will not be issued. DeBuck's is not a rain-or-shine activity, so we advise you to check the weather before your visit and come prepared. Due to mechanical, health, weather or safety conditions, we may close certain areas or attractions. We will do everything we can to re-open as soon as safely possible. The safety of our guests and staff is our primary consideration. If traveling a far distance and rain is in our forecast, you may want to consider rescheduling your visit. Inclement weather notifications and announcements of unexpected closings are posted on our Facebook page as soon as possible. DeBuck's Corn Maze & Pumpkin Patch will generally remain open during periods of light rain. However, operations are suspended if there is any threat of lightning, hail, or torrential downpours in the area. During periods of inclement weather, some and/or all activities, attractions, rides, and slides may be shut down temporarily for your safety.

Absolutely NO REFUNDS will be issued. Rain checks will only be issued when DeBuck's Corn Maze must close the entire farm property unexpectedly. By paying admission you have agreed to this policy and no exceptions will be made.

Re-admission Policy

Guests wishing to leave the farm and return the same day need to leave their admissions band on for re-entry.

Dress Code

Shoes must be worn at all times. We recommend only wearing closed-toe shoes and discourage sandals and flip-flops for your health and safety.

Guests with Disabilities

Please be aware walking paths are uneven and can be difficult to navigate. Motorized wheelchairs or chairs with larger wheels are best on our terrain. Charging stations and rentals are not available. Please let our staff know if you need assistance.
